This will cover a 4 month period and Committee members are currently evaluating the most fair and easiest to implement option. Mountbatten Update

Mountbatten Centre update on the next small phase of the centre re-opening :-

The board has now given approval that as of Wednesday 5th August we shall be opening a toilet facility downstairs. Our opening hours remain the same restricted times; 1330-1930 Wed-Fri and 1100-1700 Sat & Sun, these times will therefore apply to the toilet facility.

This will not be open to members of the public and only for commercial tenants, MBC members and MBC Staff. We feel that by opening it to a smaller number of people we are able to better control the safety measures we are putting in place and it therefore reduces the risk to all users.

This will be under constant review and therefore other times and areas remaining under constant review to be operated in full or in part with appropriate control protocols as and when it is deemed reasonably safe and indeed practicable to do so.

DBS Checks by Alan Ede

Hello everyone,

I am processing DBS checks for those that are out of date.

If you receive contact from GBG Online Disclosures please complete the online application. I will then contact you in order to verify your documents.

You may have opted for the update service at the time of the last check. This means that British Canoeing will periodically check your DBS status which does away with these 3 yearly chase ups from me.

If you did opt for the update service please let me know.

For any of you who have recently been created as an applicant by me, once you have your DBS certificate you have 30 days to register.

I am still getting my head round the update service so will post more information here later.

Other welfare related news.

The requirements for safeguarding training, (previously Paddlesafe), have changed this year. There are slight differences regarding the coach and non-coach, (helper), requirements.

In basic terms it is being tightened up and coaches, leaders and helpers will need to complete some form of training/refresher every 3 years. This will be in the form of face to face, (classroom), training or e-learning.

Again, more updates will be posted here later on this matter when I fully understand it.


Brian (Buck) Taylor by Ken Hamblin

Dear Brian

Thanks for your outstanding work at Holne Bridge and on the river Dart

I have been following the challenges around the site at Holne Bridge and Ben seal has been keeping me advised of recent developments.

I have been aware for some time of yours and Pete's truly outstanding commitment and work on this site, but wanted to take this opportunity to record my personal thanks and thanks on behalf of the staff and many members within British Canoeing, for going above and beyond over the past few weeks.

This is a very important site for British Canoeing and I know that our members and other users really appreciate being able to access it. I also know that you have done a fantastic job year round and for many years, in keeping the site clean and safe and speaking with site users, anglers and many paddlers within the south west community in particular. I appreciate that this has called for considerable skill and patience which has been tested on many occasions. Thank you so much.

I am also aware, that the challenges we have faced on the site over the past few weeks have been particularly testing and that you have dealt with these in a most professional way.

I appreciate that the recent challenges around the misuse of the site and our decision to close the site earlier than planned have been difficult to deal with. Thanks for the work you completed to install the new fencing. This probably seemed an easier task than your dealing with the reaction to the closure. I appreciate that this must have been far from easy.

Ben has advised me of the many difficult conversations with local people from Ashburton, the open water swimmers and paddlers from throughout the region and how well you have dealt with the concerns and complaints that have followed. I understand that you have been so successful in persuading people of the appropriateness of our approach that one person has even become a member of British Canoeing as a result! That really is a testament to how people feel about you.

I know from these conversations are never easy, so thanks again for dealing with these matters so well. I am sure that the steps we took were the right ones and that we will emerge with credit from this situation.

We are grateful too for your outstanding work in raising £15k from the local clubs and RDT towards the bank repair work. We know that this work would have been impossible without your involvement and commitment to fundraising. I am also aware that your work extends to other areas and that you are also active in trying to raise funds for an access point at Staverton.

As you may know our strategy is entitled *Stronger Together* and this is also one of our values within British Canoeing. We are indebted to you for your work and without it paddlers and others simply would not have the opportunity to use the site to pursue their passion. Our other values include *Striving for Excellence* and *Individually Committed* and I think you have embodied these Values in your commitment to this work over a long period of time.

Thank you very much indeed.

Please do let me know if there is anything we can do to assist you further and I hope I get the chance to visit the site and to meet and talk sometime soon.
